



#### AMERICAN STREET IMPROVEMENT PROJECT

The City of Philadelphia has received federal funding to make improvements along American Street between Girad and Indiana Avenues. The Improvements include rehabilitating sidewalks with extensions at intersections that reduce pedestrian crossing distances, new medians with green storm water infrastructure, protected bike lanes, new street trees, and new lighting. The street will be resurfaced with new pavement markings and signs installed.
